

Greater Iowa Credit Union's Dog Basket Sweepstakes

You are automatically entered into the drawing for the GICU Dog Basket Sweepstakes by completing below requirements prior to end of the day on June 30, 2024.

Official Rules

Eligibility: NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase or Greater lowa Credit Union transaction will not increase your chances of winning. Sweepstakes subject to all federal, state and local laws and regulations. Open to legal U.S. residents currently residing in lowa who are 18 years of age or older at time of entry. Void where prohibited or otherwise restricted by law. All federal, state and local laws and regulations apply. Taxes, if any, are each winner's sole responsibility.
